Topic Name: Utility of Continuing Biologic Immunomodulators

Nomination Summary: The nominator is interested in the comparative utility of continuing the biologic immunomodulators that are normally used as outpatient treatment to control chronic medical conditions when a patient is admitted into the hospital. In addition, the nominator is concerned with the detrimental effects the patients might experience from missing a dose of biologic immunomodulation, as well as the high cost of the drugs. The relevant population in which the nominator is interested focuses on low income groups. This topic is important because of the high costs and harms of such treatments. The nominator hopes that an AHRQ systematic review will identify knowledge gaps and will help develop a policy on appropriateness of purchase and administration of these drugs.

Key Questions from Nomination:

Key Question 1: When a patient is admitted to the hospital, what is the comparative utility of continuing biologic immunomodulators that are normally used as outpatient treatment to control chronic medical conditions?

Policy and/or Clinical Context from the Nomination: This topic is important because many of the biologic immunomodulator drugs are very expensive. They are mostly given as outpatient treatment on periodic (i.e., less frequently than daily) schedules.
