Programs to Treat Addictions

Results of Topic Selection Process

The topic, *Programs to Treat Addictions*, represents an important issue. However, the nomination relates to all types of addictions and associated classes of treatment, and a potential evidence review examining all interventions for all types of addictions is too broad for assessment and consideration by the program. In addition, the nominator suggested a longitudinal study to identify risk factors for addiction. This is a primary research question, and not one that can be addressed by a systematic review. No further activity will be undertaken on this topic.

Nomination Summary: The nominator is interested in the comparative benefits between different programs for treatment for patients with addictions. The population of interest is men and women over the age of 15, with subgroups including level of education, ethnicity, comorbidities, and concomitant medications. The nominator requests a longitudinal study be conducted over a ten-year span to identify risk factors in these subpopulations. Treating addictions is an important topic due to the direct harms to the individual and the indirect costs to interpersonal relationships and society. The nominator hopes an AHRQ systematic review will aid in understanding addictive tendencies, identifying the early stages of addiction, and treating the disease.

Key Questions from Nomination: For patients with addictions (i.e. gambling, shopping, alcohol, and/or street or prescribed drugs), what are the comparative benefits between different programs for treatment?

Policy and/or Clinical Context from the Nomination: This research has the potential to make a difference in the affected population, psychologically and physically.

Male and female > 15 years of age, longitudinal design, add in education, ethnicity, comorbid conditions and concommitant medications over time. Do a study if identifiable risk factors can be found longitudinally similar to the NHANES and Framingham studies.

Treat each type of addiction ie. gambling, alcohol, drug/substance abuse, shopping as a subgroup along with 10 year age cohorts, ethnic groups, and if possible stage of disease.
