


Program Goals Achieved

The **vision** of the Agency for Healthcare Research and Quality's (AHRQ) Evidence-based Practice Center (EPC) Program is that all healthcare decisions are based on the best available evidence, resulting in the best possible health outcomes; the **mission** is to transform healthcare by increasing the quality, availability, and use of evidence via scientifically rigorous and unbiased analysis of evidence. To accomplish this mission, the Program has **four goals**:

AHRQ Rapid Responses Inform CMS Coverage Decision for Dental Care

EPC Report: Efficacy of Dental Services for Reducing Adverse Events in Those Receiving Chemotherapy for Cancer

Why: Although oral health is inextricably linked to overall health, coverage for dental services is not always available via Medicare but may be particularly important for patients with cancer receiving chemotherapy. Chemotherapy suppresses the immune system, rendering patients more susceptible to infections of all kinds including infections of the mouth, teeth, and gums

Who: The Centers for Medicare & Medicaid Services (CMS) requested evidence review from AHRQ to determine the effectiveness of providing dental care for patients receiving chemotherapy.

How: Findings from a rapid response review showed that prechemotherapy dental care may reduce the incidence and/or the severity of infections of the mouth and jaw.



What: The CMS Physician Fee Schedule, updated annually, is a complete listing of fees Medicare uses to pay doctors or other providers/suppliers. Inclusion of dental coverage for people who would receive chemotherapy for cancer removes an important barrier to the receipt of dental care and improves cancer-related outcomes. Findings from this review informed a change in the CMS physician fee schedule to provide Medicare coverage for patients with cancer receiving chemotherapy. This change may improve treatment outcomes for patients with cancer as well as address disparities among those unable to afford dental care.

American College of Obstetricians and Gynecologists Creates Perinatal Mental Health Clinical Practice Guidelines Using AHRQ Research

EPC Report: Maternal, Fetal, and Child Outcomes of Mental Health Treatments in Women: A Systematic Review of Perinatal Pharmacologic Interventions



Why: Obstetrician-gynecologists want to improve care for their patients and need clinical guidance when medications can affect both the mother and the unborn child.

Who: Mental health conditions (including deaths from suicide and overdose/poisoning related to substance use disorders) are the leading cause of pregnancy-related death. Nearly a quarter of all maternal deaths can be attributed to mental health causes.

How: The EPC conducted a systematic review to assess the benefits and harms of pharmacologic interventions compared with placebo, no treatment, or other pharmacologic interventions for pregnant and postpartum women with mental health disorders. The EPC synthesized the results of total of 164 studies and found low-quality evidence on the benefits of some medications for postpartum depression and for continuing mood stabilizers during pregnancy, and limited evidence for harms. However, most studies reporting on harms were observational and unable to fully account for confounding.

What: The American College of Obstetricians and Gynecologists published a clinical practice guideline, Treatment and Management of Mental Health Conditions During Pregnancy and Postpartum, based on the AHRQ systematic review. This guideline has 14 recommendations on treatment and management of perinatal depression, anxiety, bipolar disorders, and acute postpartum psychosis. It focuses on psychopharmacotherapy and outlines specific steps for initial and followup treatment of perinatal mental health conditions.

AHRQ Studies Impact of Healthcare Algorithms on Racial and Ethnic Disparities

EPC Report: Impact of Healthcare Algorithms on Racial and Ethnic Disparities in Health and Healthcare

Why: Algorithms are ubiquitous in healthcare and used for diagnosis, treatment, and the allocation of resources. Bias in the development and use of algorithms can worsen outcomes for racial and ethnic minorities and other underserved groups.

Who: In September 2020, Congress requested an AHRQ systematic review to examine the impact of healthcare algorithms on racial and ethnic disparities.

How: AHRQ issued a Request for Information (RFI) and completed and published an evidence review on the impact of healthcare algorithms on racial and ethnic disparities in health and healthcare. In addition, AHRQ



convened an interdisciplinary panel of leaders in healthcare to develop and publish guiding principles to address the impact of algorithmic bias on racial and ethnic disparities in health and healthcare.

What: In addition to the published report, the results of the RFI and the guiding principles were published in prominent journals and call for attention and action on the issue. The guiding principles advocate for the creation of systems and policies to support transparency, community engagement, and accountability in the development and use of algorithms in healthcare, thus promoting health and healthcare equity for racial and ethnic minorities and other vulnerable groups.

Sustained Impact of Work Related to EPC Reports Over Time

We assessed the amount of attention received for manuscripts published since 2010 and associated with an EPC report. Our assessment utilized Altmetric, which ranks manuscripts and other products based on the attention they receive using data such as the number of times they are mentioned in the news or by the public in social media, and the number of times they are cited. For the 275 EPC report-associated journal manuscripts published since 2010, there have been 17,617 mentions so far. Of the top 20 articles that have received the most attention, all are in the top 5 percent of research products scored by Altmetric. The top three articles, per the Altmetric attention ranking, include the following articles:



Meditation Programs for Psychological Stress and Well-Being, (published in JAMA Internal Medicine in March 2014), has been cited 1,575 times and mentioned 1,845 times, including mentions in 66 blogs and in 684 news stories from 309 news outlets. The associated AHRQ systematic review was mentioned in 61 news stories from 26 outlets.



Over-the-Counter Supplement Interventions to Prevent Cognitive Decline, Mild Cognitive Impairment, and Clinical Alzheimer-Type Dementia (published in Annals of Internal Medicine in December 2017), was mentioned 1,232 times, including mentions by over 1,100 users of X (formerly Twitter) and in 91 news stories from 87 news outlets. The associated AHRQ systematic review was mentioned in 12 news stories from 10 outlets.



Cannabis-Based Products for Chronic Pain (published in Annals of Internal Medicine in August 2022) has been mentioned in 121 news stories from 110 outlets. This manuscript was recognized by the American College of Physicians Annals of Internal Medicine as one of the best articles of 2022.
